FOREIGN LANGUAGES EDUCATION	English Language Teaching	Master's Degree	2	A bachelor's degree in English Language Teaching, English Language and Literature, American Culture and Literature, English Linguistics, Applied Linguistics, Translation Studies or Translation and Interpreting from a university in Türkiye or abroad, with an undergraduate GPA 2.75 out of 4 or 70 out of 100. Foreign applicants must have a score of 85 from YDS (English) or an equivalent score from International English language exams (TOEFL IBT, CAE, CPE, PTE Academic) accepted by the Interuniversity Board (ÜAK) and the University Senate, which measure four basic language skills. Some of the accepted exams and minimum scores are listed below. TOEFL (IBT): 102; PTE Academic: 81; CPE: B; CAE: A for equivalent foreign language exam scores determined by the Higher Education Council (YÖK): https://denklik.yok.gov.tr/Documents/EsdegerlikTablosu.pdf

A-APPLICATION AND ADMISSION REOUIREMENTS

- 1. Applications must be made to Erciyes University Institute of Educational Sciences in person or through a notary public proxy.
- 2. For foreign candidates to be admitted to graduate programs, they must have a diploma from a higher education institution in Türkiye or a diploma from an institution whose undergraduate or graduate education is accepted as equivalent by the Council of Higher Education.
- 3. Foreign students who graduated from a bachelor's or master's degree program abroad must have a <u>C1 level Turkish proficiency certificate</u> from the Turkish Education Centers of State Universities and a certificate of equivalence of the diploma accepted by YÖK.
- 4. For admission to the PhD program, candidates must have a master's degree. Candidates applying with a master's degree must have a grade point average of at least 2.5 out of 4.
- 5. For admission to the Master's program, candidates must have graduated from an undergraduate program. Candidates applying with a bachelor's degree must have a grade point average of at least 2 out of 4.
- 6. Foreign students who will apply to the PhD program whose medium of instruction is Turkish must have a minimum score of 66 from TOEFL-IBT exam or a minimum score of 55 from YDS listed in the YÖK equivalency table or a minimum score of 50 from PTE ACADEMIC exam (other than their native language)
- 7. Foreign students who graduated from an undergraduate or graduate program abroad must have a <u>Turkish proficiency certificate (C1 Certificate)</u> from the Turkish Education Centers of State Universities. Those who do not have a Turkish proficiency certificate can start their education in the program they enrolled in after receiving Turkish preparatory education and obtaining a Turkish proficiency certificate after admission and registration procedures. Turkish proficiency certificate is not required in departments that provide education in a foreign language.
- 8. <u>Turkish proficiency certificate (C1 Certificate)</u> is not required for foreign students who completed their undergraduate and graduate education in Türkiye.
- 9. Applicants must have a diploma equivalency certificate accepted by the Council of Higher Education (YÖK).
- 10. Graduates of master's degree with Thesis can apply to PhD programs.





- 11. Candidates must meet all application requirements; the applications of those who do not meet the announced departmental requirements will not be evaluated.
- 12. If they submit the original documents required by the Graduate School, they can apply to master's or doctoral programs. Missing documents and false statements are the responsibility of the applicant. Those who make false statements and falsify the requested documents will not be registered. Students who are registered according to untrue information and documents are deregistered.
- 13. Candidates will be evaluated on the basis of their application files.

B-DOCUMENTS REQUIRED FROM CANDIDATES

- 1. Application form
- 2. Applications must be made to the student unit of the Institute of Educational Sciences in person or through a notary proxy.
- 3. Photocopy of identity card.
- 4. One (1) passport size photograph
- 5. Those who do not have a Turkish Proficiency Certificate (C1 Certificate) will be enrolled, but they will be able to start classes after obtaining the C-1 certificate as a result of Turkish preparation.
- 6. Foreign Language Certificate (other than their native language for Turkish PhD program),
- 7. Sample passport with entry visa and certified Turkish translation
- 8. Diploma or graduation certificate and certified Turkish translation
- 9. Transcript and certified Turkish translation
- 10. Certificate of Equivalency (must be obtained from the Higher Education Institution)

C-FINAL REGISTRATION

1. The announcement of the final registration and reserve lists will be announced on the official web <u>https://ebil.erciyes.edu.tr/</u> page of Erciyes University Institute of Educational Sciences Directorate on the specified dates.

2. Final registration will be made in person.





3. Provisional registrations of the candidate students who are entitled to final registration will be made; Students who are covered by GSS (General Health Insurance) after making GSS (General Health Insurance) from the Social Security Institution will be registered if they submit the receipt that they have paid the necessary premiums to the Presidency of the Social Security Institution and the document that they have registered to GSS (General Health Insurance) to the student affairs office of the Institute.

4. For the right to register from the reserve quota; candidates must submit a petition <u>to the student unit of the Institute of Educational Sciences</u> on the specified dates.

5. Candidates who do not take action on the specified dates will be deemed to have waived their rights.

6. Students whose provisional registration or final registration has been made with false information and documents will be deregistered.
